1. Grant of License

4. Consent

5. Warranties

- You are declared bankrupt, go into liquidation, have a receiver or other controller appointed, or (being a company) are wound up otherwise than for the purpose of a reconstruction;
- d. Either GS1 Pakistan or You may terminate this Membership Agreement and License in any other circumstances by giving six months' written notice to the other party.
- e. Termination of this Membership Agreement and License does not relieve either GS1 or You from liability arising from any prior breach of the terms of this Agreement.

15. Consequences of Termination

a. On termination of the Membership Agreement, your rights under this Agreement terminate and You must:

- The termination or expiry of this Agreement does not affect those provisions, which by their nature survive termination, including clause 12 and 13.
